



PRIVACY NOTICE AS PER ARTICLE 13 OF REGULATION (EU) 2016/679.

1. Introduction

In accordance with article 13 of European Regulation (EU) 2016/679 (“**GDPR**”), ISENET Biobanking S.r.l. (the “**Company**” or the “**Data Controller**”) is providing the following information regarding the processing of personal data to inform the users (“**Users**”) of the www.isenetbiobanking.com (the “**Website**”).

2. Who is the data controller?

ISENET Biobanking S.r.l., an Italian company with registered office in Milano, via Calabria, n. 31, VAT Number n. 10416360963, is the Data Controller.

3. What kind of personal data is processed by the Company?

The Company collects and processes the following personal data provided by the Users (the “**Personal Data**”):

- a) the identification data such as name, surname, e-mail address, telephone number provided by the Users asking to be contacted or forwarding an alert through the “Request Information” section on the Website;
- b) the navigation data provided by the Users while browsing the Website and relating to the use of the services offered through the Website collected through cookies in accordance with the information on cookies available at the following link www.isenetbiobanking.com/cookie-policy

4. For what purposes is the personal data processed?

The Company processes the Personal Data through manual and electronic means in order to:

- a) provide the services requested by the User while browsing the Website or for the subscription to the Newsletter and Mail Alert services whereby forms are filled out on the Website, which require the acquisition of user contact data for the distribution of the requested service. (hereafter referred to as “**Contractual Purposes**”);
- b) comply with applicable laws and legal procedures and to respond to requests from the relevant government authorities (the “**Compliance Purposes**”);
- c) with the consent of the User, send newsletters and marketing communications, through traditional and electronic means, for the promotion and / or sale of products and / or services provided by ISENET Biobanking S.r.l. and for customer satisfaction surveys (“**ISENET Biobanking Marketing Purposes**”);

- d) with the consent of the User, send newsletters and marketing communications, through traditional and electronic means, by other companies belonging to Air Liquide Group, for the promotion and / or sale of their products and / or services provided by these companies and for customer satisfaction surveys ("**Air Liquide Group Marketing Purposes**").

5. On which legal basis is the personal data processed?

The processing of the Personal Data for the Contractual Purposes and Compliance Purposes is necessary for the performance of the services related to navigation on the Website and for the compliance under applicable laws. The refusal to provide the personal data for such purposes would prevent the Company from performing the services and, if already entered, to continue its performance.

The processing of the Personal data for ISENET Biobanking Marketing Purposes and for Air Liquide Group Marketing Purposes is optional and may be revoked at any time through the Contacts section

6. How long do we retain your personal data?

The data will be stored for a period of time not exceeding that necessary for the purposes for which they were collected or subsequently processed in accordance with the provisions of the legal obligations.

7. Who has access to the personal data?

The Company might communicate the Personal Data to other entities of the group or third parties service providers that carry out activities instrumental to the Company to perform the Agreement, that are appointed as processor when required by applicable laws and include: cloud service providers, IT service providers, experts, consultants and lawyers, companies resulting from possible mergers, demergers or other transformation, as well as competent authorities, when allowed under applicable laws.

8. Is the personal data transferred abroad?

The Personal Data may be transferred to countries outside the European Economic Area because the Company uses a Cloud Provider based in United States of America.

including through inclusion in shared databases and managed by third parties belonging or not to Eni SpA's The Owner will take all appropriate contractual measures necessary to guarantee an adequate level of personal data protection in accordance with that stated within the present information document on the processing of personal data, including, among others, the Standard Contractual Clauses approved by the European Commission.

9. What are your rights with regard to your Personal Data?

The Users, at any time, may exercise the following rights:

- a) the right to be informed on the purposes and methods of the processing;
- b) the right of access;
- c) the right to obtain a copy of the Personal Data held abroad and obtain information concerning the place in which such data are kept;
- d) the right to ask for updating, rectification or integration of the Personal Data;
- e) the right to request the cancellation, anonymization or blocking of the Personal Data;
- f) the right to restriction of the processing only where one of the following applies: (i) the data are not accurate or updated; (ii) the processing is proved unlawful; (iii) the data are required for exercise or defence of legal claims; and (iv) the data subject has objected to the processing;

- g) the right to object to the processing, wholly or partly, also where it is carried out through automated individual decision-making, including profiling;
- h) the right to revoke the consent to the processing of the data freely and at any time;
- i) the right to contact the data protection officer;
- j) the right to data portability;
- k) the right to lodge a complaint in front of the competent national data protection or judicial authority.
